- CANDELABRAS OR CANDLE STANDS WILL REQUIRE DRIP TRAYS OR MATS TO PREVENT DAMAGE TO LINEN AND CARPETS.
- ANY LOSS OR DAMAGE TO PROPERTY INCLUDING LINEN, BEYOND REASONABLE WEAR AND TEAR WILL BE CHARGED FOR ACCORDINGLY.
- NO FIREWORKS, SKY LANTERNS OR HELIUM BALLOONS ARE ALLOWED TO BE RELEASED FROM RUIMSIG COUNTRY CLUB.

PAYMENT TERMS

INITIAL PAYMENT

- A 50% DEPOSIT IS REQUIRED UPON CONFIRMATION OF BOOKING IF MORE THAN 14 DAYS PRIOR TO EVENT. THIS INITIAL PAYMENT WILL SECURE YOUR DATE WITH JESSENCE TRADING (PTY) LTD AND IS NON-REFUNDABLE SHOULD YOU CANCEL OR POSTPONE YOUR EVENT.

FINAL PAYMENT

- BALANCE OF INVOICE AMOUNT IS TO BE PAID 7 DAYS PRIOR TO YOUR DATE, AS WELL AS FINAL NUMBERS ARE TO BE CONFIRMED. FULL PAYMENT IS REQUIRED IF BOOKING IS MADE WITHIN 7 DAYS PRIOR TO EVENT. NON-REFUNDABLE SHOULD YOU CANCEL OR POSTPONE YOUR EVENT.

DEPOSIT: IN THE EVENT THAT YOUR CONFERENCE IS POSTPONED, A NEW INITIAL PAYMENT OF 50% OF QUOTED AMOUNT MUST BE MADE TO SECURE YOUR NEW DATE.

CANCELLATION POLICY
